NOTES ON INTER-COUNTY TRANSFER APPLICATION FORM

(A) The player seeking the transfer must sign his name in Irish and English at (1), having filled in the name of the club he wishes to leave and the one he wishes to join, his address and the grade in which he is currently playing (senior, junior or minor).

The County Secretary of the club he wishes to join must sign at (2) and forward the form to the County Secretary of the club he wishes to leave.

(B) The County Secretary of the club from which the player wishes to be transferred must sign at (4) and get the club secretary from which the player is leaving to sign at (5).

(C) The completed form is then sent to the Secretary of Comhairle Uladh, at the address below:
